Dogs MUST have a UKC registration or listing # to be entered.

REFUNDS: Requests received prior to closing date will be honored, subject to a \$5.00 administrative fee.

Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the Show cannot open or be completed by reason or riots, civil disturbances, fire, extreme &/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee.

Returned Checks do NOT constitute valid entry fee. The club will add a \$25.00 fee for each returned check.

The Show giving club, their agents & employees, etc., assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property.

The show site will be open at Noon Fri. and at 6 am. Sat. & Sun.

Crating space available indoors.

Only exhibitors that have dogs entered in obedience or agility may leave crates overnight (at your own risk).

Rally only exhibitors must remove crates.

NO DOGS may be left overnight.
