Saturday - Fullhouse, Standard 1, Standard 2, Snooker and Jumpers. Order will be Tall to Small.

Sunday - Jackpot, Standard, Snooker, Wildcard and Colors. Order will be Small to Tall.

### **Directions to the Trial Site: 2390 West Lake Boulevard, Davenport, IA**

**From the North:** Take US 61 or I-88 to I-80 W, to I-280 E. Exit at Iowa Exit 4, West Locust St and turn right. Proceed one block to West Lake Blvd (at the Honda sign) and turn right.

**From East:** Take I-80 to I-74, to I-280 W, crossing the Mississippi River. Exit at Iowa Exit 4, West Locust St and turn left. Proceed one block to West Lake Blvd (at the Honda sign) and turn right.

**From South:** Take I-74 West to I-280 West, crossing the Mississippi River. Exit at Iowa Exit 4, West Locust St and turn left. Go one block to West Lake Blvd (at the Honda sign) and turn right.

**From West:** take I-80 East to I-280, follow to Exit 4, West Locust St and turn right. Proceed one block to West Lake Blvd (at the Honda sign) and turn right.

**Quad City Dog Center is at 2390 West Lake Boulevard, across from Honda plant.**
