Trial Limit - 125 runs per day total all events

Pre-entries will be accepted on a "first received" basis **beginning Wed, April 13, 2016.** No entries accepted prior **to** this date. Pre-entries will **close Wednesday, June 15, 2016** or when entry limits have been met. A wait list will be kept if trial fills. Day of Entries will close day of trial at 7:30 a.m. on Saturday and Sunday, or when entry limits have been reached, at which time entries cannot be accepted, canceled, altered or substituted except as provided for in UKC Dog Show Rules

A fee of \$25.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. Faxed entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

Trial Information- Notice to Exhibitors

A UKC PT or NACSW ORT is required for entry in a UKC element title trial for the level/odor entered. Copy of PT or ORT should be sent with entry.

For pre-entries if you do not pass the required PT test in the morning the club will refund you the element trial entry fees that were pre-paid. This is to encourage pre-entries.

"A" Section Classes - This section is open to all exhibitors and dogs that have not earned a title in the element in which they are entering or equivalent title in another organization. The exhibitor must own the dog entered or be a member of the owner's household or immediate family. Once the dog has earned the title they may no longer compete in the "A" section. No licensed or professional dog trainer or Nosework instructor, regardless of the person's status as an amateur or professional, may compete in this section. No person licensed to officiate Nosework in UKC or any other organization may compete in this section.

Exhibitors with more than one dog entered in a trial. Exhibitors may handle only one dog in each class, or element in each trial. An exhibitor may enter more than one dog in the same class or element so long as a separate handler is provided for each dog. Exhibitors may enter and handle more than one dog per trial provided the additional dog(s) are entered in a different class or element from all other entries being handled by that exhibitor.

A UKC registration number is required to participate in these trials. For information on UKC registration go to www.ukcdogs.com.

Crating space will not be available indoors and handlers will need to plan to work from vehicles.

Food will not be available for purchase onsite. Please plan accordingly.

Photographer Sheryl McCormick will be on hand both days of the trial to take pictures.
